Elena Kagan confirmed as US Supreme Court justice

Elena Kagan was confirmed by the U.S. Senate as the 112th Associate Justice of the U.S. Supreme Court on August 5, 2010.

Replacing retired Justice John Paul Stevens, Kagan is just the fourth woman to serve on the Supreme Court.

Elena Kagan was previously Solicitor-General of the United States.

Equal pay by 2067--maybe

Equal pay for women in the UK is not likely till 2067, says research from the Chartered Management Institute (CMI).

Forty years after the Equal Pay Act was passed, the study shows that the gender pay gap remains stubborn and that male and female managers will not be paid the same for another 57 years. Women have also been harder hit by the recession, with more female workers than men being made redundant in the past 12 months.

CMI has launched an "ambitious women toolkit" with practical advice on asking for pay rises, how to challenge unequal pay, and tips on returning to work from maternity leave.

UN Women established

On 2 July the United Nations General Assembly unanimously voted to establish the United Nations Entity for Gender Equality and the Empowerment of Women. Thankfully, it is to be known as "UN Women" rather than the somewhat less-inspirational acronym, "UNEGEEW".

Once it begins operation in January 2011 UN Women will supplement, rather than replace, the work of other UN entities working towards gender equality and women's empowerment. Its two key roles will be to support inter-governmental bodies in formulating policies, standards and norms and to assist countries to implement these standards when requested, through the provision of technical and financial support. Additionally, it will monitor progress towards meeting the UN's own commitments on gender equality.

The UN system has to this point lacked an effective driver on gender equality issues and this development is long over-due. UN Women is certainly a step in the right direction, but for it to succeed in achieving a more just world for women it will require sufficient political support and financial resourcing.

Helping UN Women to rise to the challenge of becoming the "dynamic and strong champion for women and girls" its creators envisage is something we can all contribute to in the coming years.
